As one of three attorneys in the National Office of the March of Dimes, Laurie developed considerable familiarity with the governance and other challenges facing national chapter based non-profit organizations. As a member/officer of the Lake Forest Board of Education for eight years, Laurie led and worked with consensus-based teams on a broad variety of projects and initiatives. As a member of the Representative Town Meeting (municipal legislature) in Greenwich, CT, she facilitated the creation of a Scenic Roads Ordinance. Laurie's community service also includes the Tri Con Child Care Center, the LF/LB Newcomers Club, Applause, Spirit of 67, Piven Theater, the Psychiatry Advisory Council for Northwestern Memorial Hospital, and the Yale Alumni Schools Committee. She currently serves on the Zoning Board of Appeals in Lake Forest.

We are living in an historic time in which the very definition of democracy is subject to debate. Sound fiscal policy and planning for LWVIL is imperative. Enhancing service and support to local Leagues should be prioritized along with the development of a more clearly articulated and unified approach to governance and oversight. Increased opportunities for self-reflection and metrics for assessment could be implemented along with a comprehensive review of policy. Monthly opportunities for learning finance, governance, and technical skills could take place via webinars and in person meetings.
