# **Letter from the President, August 2020**

Dear League members and friends of the League,

Last week we observed the 100th anniversary of the ratification of 19th amendment. Last week, for the first time in our history, a woman of color was named as a candidate for vice president on a major party ticket. Last week we witnessed the dismantling of the US Postal Service, a direct threat to vote by mail and the safety of voters during a pandemic. Last week the number of those lost to the pandemic rose to 174,000.

Last week.

And this week? Make this a week of renewed dedication to our League mission to ensure all eligible voters are registered and have access to the ballot. USPS "reforms" that will result in postal service disruption are a type of voter suppression. As League members, we are compelled to right this wrong.

Take action now:

- If you plan to vote by mail, apply for your vote by mail ballot as soon as possible.
- Ensure that your family, friends and neighbors, understand that voting by mail is safe and secure.
- Attend our webinar on Wednesday, August 26th stay current and educate other voters.
- Contact our Senators and your representatives in Congress and tell them to support the USPS.

Our dedication as League members is essential to our democracy and we call on our elected officials to defend the safety and integrity of our election in this time of pandemic. Together our work stands before us.

Beyond this week. Beyond this election. Into our second century.

# Local League Input Needed

Before <u>Illinois Voter Guide</u> goes live in September, LWVIL is collecting candidate questions from local Leagues. Instructions have been sent to local League voter service contacts for submitting questions for any state, county or local race. Please submit questions by **August 21**; contact <u>VoterService@lwvil.org</u> if that date is an issue, if you need access to the submission link, or if you need help entering questions from your League.

#### **Pollwatchers**

If your League is interested in observing Election Day at polls in your area or wants to observe counting/recounting of ballots, your League MUST request poll watching credentials by **September 24**. Apply with <u>your local Election Authority</u>.

# **Election Workers Needed**

Election Judges/Polling place technicians are essential for ensuring voter access! Each election authority has specific requirements and duties for judges and technicians, all election authorities need workers. This year, students 16 years of age or older are eligible to be poll workers. Check requirements with <u>your local election authority</u>.

Typical duties include:

- Opening the polling place at 6 a.m. sharp and closing it at 7 p.m.
- Setting up election equipment
- Verifying voter qualifications
- Operating voting equipment
- Processing and transmitting votes when polls close
- Certifying vote totals

# **Support a Fair Tax in Illinois**



Our best hope of funding programs that address problems highlighted during the COVID-19 pandemic is through a Fair Tax. The Fair Tax would raise taxes on the only segment of society which has seen an increase in income in recent decades – *people earning over \$250,000.* The amendment will be at the top of our ballot November 3.

The League has supported a graduated rate income tax (Fair Tax) for the past 50 years as a path to equitable and adequate funding for programs supporting education, health, and human services.

# **Time for Action: Clean Energy Jobs Act**

<u>CEJA (Clean Energy Jobs Act) (SB2132/HB3624)</u> is part of a bold recovery effort to build a strong, equitable economy and healthier, more resilient communities. CEJA will boost one of the fastest growing industries- clean energy-, by creating new, well-paying jobs and reducing utility bills for families and businesses struggling to make ends meet.

Additionally, CEJA will improve public health by reducing air pollution that have weakened the respiratory health of communities on the frontlines of this pandemic.
