On January 1, 2024, Illinois SB2123 went into effect, allowing eligible 16 and 17-year-olds to pre-register to vote. Eighteen states and Washington, D.C. already permit voter pre-registration beginning at age 16. In Illinois, eligible teens may now pre-register, but will not receive a ballot until they reach voting age.

A big round of applause goes to LWVIL Issues & Advocacy Director Tina Brady Pettis, who took the initiative to coordinate and produce 2024's kickoff voter pre-registration event at Simeon Career Academy. On January 17, this event was able to register and pre-register more than 250 voters!

Tina is the founder of the GOTV 4 TEENS coalition, which includes the League of Women Voters of Illinois, Coalition of African American Leaders, CHANGE Illinois, Chicago Votes, Girls Of Grace Youth Center, National Pan-Hellenic Council Of Chicago, Neighbors Who Vote, Never 99, Promote The Vote Illinois, Simeon Alumni Association, Target Area, The Leaguers, Voices Of West Englewood, and local chapters of the Alpha Phi Alpha Fraternity, National Council of Black Women, National Council of Negro Women, and Top Teens of America.

Support Humane Treatment of Immigrants

During the past many months, we have witnessed our municipal governments react to the challenge of increasing numbers of buses or planes arriving in our communities with immigrants. While some communities have approached the situation through a lens of compassion, others have implemented restrictions on the transportation and housing critical to their journey, and others have attempted to restrict state and federal funding necessary to alleviate what has become a humanitarian crisis.

Whatever the reaction in your community, LWVIL is assembling a set of resources to assist you with responses your local League can use to speak up and advocate for humane treatment of new arrivals.

What has been done so far?

LWVIL President Becky Simon <u>published a letter to the editor of the *Chicago Tribune* to stand for humane treatment of immigrants and to call for a coordinated effort across the state to address the issue.</u>

The LWVIL Issues and Advocacy Committee created <u>Talking Points for Leagues</u> to help you draft and discuss the issue locally.

And finally, the League of Women Voters of McLean County, armed with <u>talking points</u>, spoke against a resolution proposed by a member of the McLean County Board to ban the use of county tax dollars and refuse to accept federal funds if needed to support migrants. The resolution was rejected 13-7. Congratulations and thank you to Diana Hauman, president, and to the McLean County League! After the meeting, Diana shared the following, "It was good to see our community come together as we did to try and protect the rights of others. Over 40 people spoke at public comment."

Election Day is March 19

Coming up in Illinois is the <u>Primary Election</u> on Tuesday, March 19!
Use <u>IllinoisVoterGuide.org</u> to register to vote, check on your registration status, sign up to vote by mail, or apply to be a poll worker. Spread the word with this <u>handy</u> <u>calendar</u> in your League newsletters or on social media.

As of January 1, sixteen and younger seventeen year olds may pre-register to vote, with their registrations held in abeyance until they reach voting age.

For League purposes when holding registration drives, the only difference in registering these teens versus other voters is that the pre-registrants can only register **online** or **at the DMV**. Otherwise, the requirements remain the same: direct them to <u>ova.elections.il.gov</u>, where they'll be asked for their driver's license or state ID number, and the last four digits of their SSN.

For older teens who will be eighteen by election day on November 5, 2024, they can register in all the usual ways—online, in-person at the election authority or DMV, paper form or mail-in registration. They can also vote in the March 19 Primary Election.
