# **Get Out the Vote This Spring**

Congratulations to all local Leagues on unprecedented voter education efforts during this unique election. Efforts now turn to the Consolidated Election on April 6, with some communities holding Primary elections on February 23.

Record voter turnout of 72.9% during the general election is inspiring as we seek to maintain voter intensity for the upcoming Consolidated and Midterm elections. Local Leagues are encouraged to refer to this 2020 <u>summary of local League actions</u> for ideas about how to improve voter turnout this spring.

## **Illinois Voter Guide: Consolidated Elections**

The <u>Illinois Voter Guide (IVG)</u> will cover candidates for municipal offices in Illinois towns with populations of 10,000 or more. All school district races in Illinois will be covered.

However, IVG will not cover township, park district, library district, and other special districts. This is due to continued development of Geographic Information System (GIS) data, which does not allow our vendor to map races for all sample ballots.

Please contact <u>LWVIL Voter Service</u> for voter guide strategies for smaller municipalities and special districts.

IVG will once again support your questions for candidates. LWVIL will share a link in January asking local Leagues for questions and candidate emails, and IVG will contact candidates directly for responses.

# **Candidate Forum Participation: Policy Revision**

Candidate forums held by Zoom in response to COVID-19 safety concerns resulted in higher than usual forum attendance for many Leagues. However, some Leagues still had candidates who chose not to participate. Lack of candidate participation is a concern due to potential violations of FEC, and possibly FCC and IRS, fairness rules regarding the appearance of federal candidates without opponents in a debate or forum.

For state and local candidates, LWVIL policy is that Leagues follow the same empty chair policy as they do with federal candidates and not hold a forum with only one candidate.

Per LWVIL recent policy revisions: If a non-Federal candidate does not choose to participate, and there is only one candidate appearing, while there will not be a forum, their opponent may be afforded the opportunity of a two-minute statement, only to outline their platform. The policy does not allow a two-minute statement for a sole federal candidate.

Some Leagues send questions to candidates and ask them to return videos with their responses. This is not a forum and is more like a Q&A found in a voter guide. We encourage Leagues who follow this Q&A video style to make every attempt to receive a response from all candidates in a race.

# **Criminal Justice Position Update Study: Consensus Meetings Underway**

Thanks to the hard work of local League Criminal Justice Update Study Committees, this project is successfully coming into the home stretch!

All Leaguers are encouraged to attend consensus meetings! This is a great opportunity to give your input about the position update, which will allow us to advocate for improvements to our current criminal justice system.

For those who are interested in a deeper look at the issues prior to attending a meeting, there are a wide variety of <u>resources on our website</u>. There are 14 consensus questions that will be presented, pro and con, at the meetings. Your committee members will make sure there is plenty of time for discussion so that your group can reach consensus.

Remember, consensus is general agreement. It is not a vote. Your League's consensus, lack of consensus, and general comments are vital to updating the LWVIL Criminal Justice Position, which will be voted on during Convention.

# **Program Planning**

It is time for local Leagues to begin working on LWVIL's program of study and action for the 2021–2023 Biennium.

When your League puts out a call for Program Planning, get involved! Member input helps provide the tools to actively engage in public policy change at local and state levels. This is your opportunity to help shape League action for the next biennium.

# Leadership Term Limits: Does the League Have a

### **Position?**

Establishing term limits for legislative leadership positions is one of nine ethics reforms proposals currently advocated by 16 Illinois Senate and House Democrats.

Their advocacy is based on preventing an individual from accumulating and retaining power at the top of the elected legislative body.

LWVIL does not have a Position regarding term limits for legislative *leadership positions*. However, LWVIL does oppose legislative term limits because they have the following negative effects:

- Restricting voter choices.
- Increasing the number of inexperienced representatives making policy decisions.
- Forcing the best legislators into retirement with no consideration for their effectiveness.
- Causing novice legislators to fill their informational and policy gaps with increased reliance on special interests and lobbyists.

# **Request for Proposals to Amend LWVIL Bylaws**

Proposals for any Amendment to the LWVIL Bylaws must be submitted to the Board of Directors no later than **March 12**, three months prior to convention.

# **Remembering Syvia Tillman**

March 13, 1931 – November 3, 2020

A lifelong advocate for citizens' rights, education and labor, Syvia Tilman was a dynamic contributor to the League, both on a local (Homewood-Flossmoor) and state level. With her passing on Election Day, the community lost an active, energetic ally who made sure her last vote counted.

Born and raised in Nebraska, Tillman held a degree in PolySci from University of Nebraska. She spent her life working in Illinois, as Administrative Assistant to State Rep Anthony Scariano, then as head of the Governor's Action Office under Governor Dan Walker. She moved to the Department of Registration & Education and became Deputy Director of the Department of Labor, where she was actively involved in negotiating labor contracts until she retired.

Upon retirement, Tillman joined the Homewood-Flossmoor League of Women Voters (2000), serving as President (2002-03 and 2008-09) and co-president (2009-11). She joined the LWVIL Board of directors in 2003, becoming VP of Membership (2005-07) and VP of Issues (2007-09).

In addition to her League activities, Syvia was deeply involved in her community and was especially dedicated to improving race relations in the south suburbs through

<u>Diversity Dinners</u>. She received the Carrie Chapman Catt Award at the 2015 LWVIL convention for her outstanding League leadership and community involvement. A more detailed look at Syvia's life can <u>be found here</u>.
