Ensuring Accuracy of Information

The LWWIL **Leaders Update** is the primary vehicle by which important information and updates are received by local leagues and their members.

It is vital that each local league send us a list of contact information for all local league leaders, including title, mailing and e-mail addresses.

LWWIL is moving from mailing through the USPS to a system of electronic communication so current e-mail addresses are especially important.

A form entitled, "**Local League Contact Information**" was e-mailed by LWWIL to all e-mail addresses in our local league leader database asking that the form be completed and returned to the LWWIL office.

Thank you to these Leagues which have responded to the request: Champaign County, Chicago, Downers Grove/Woodridge/Lisle, Evanston, Jackson County, Kewanee Area, LaGrange Area, Lake Forest/Lake Bluff, Glen Ellyn, Greater Peoria, Greater Rockford Area, McHenry County, Homewood/Flossmoor, Park Forest Area, Palos/Orland Area, Jo Daviess County, Roselle /Bloomington, Cook County and Lake Michigan Region.

In Illinois, there are 41 local leagues, 1 MAL unit and 3 ILOs. That means that 57% of local leagues, etc. have **not** responded.

TO THOSE LEAGUE LEADERS WHO ARE RECEIVING AND OPENING THIS E-MAIL: if your League is **not** among those listed, we would appreciate your effort by helping us complete the information or ensure that it gets to the person who is able to
